

AMC National Registry Eligibility	Any AMCs registered in Texas must submit responses on an annual basis, regardless of whether it meets the requirements to be on the AMC National Registry. This is separate and distinct from the AMC registration renewal that is done every two years.	
Application Summary	TALCB is required to transmit data and fees to the ASC on an annual basis. The AMC Registry fee is \$25 per appraiser panelist that performed an appraisal in connection with a covered transaction in Texas in the last calendar year (January 1 through December 31). A covered transaction is defined as any consumer credit transaction secured by the consumer's principal dwelling. The fee is based on the number of appraiser panelist you report and is automatically calculated at the end of this transaction.
