

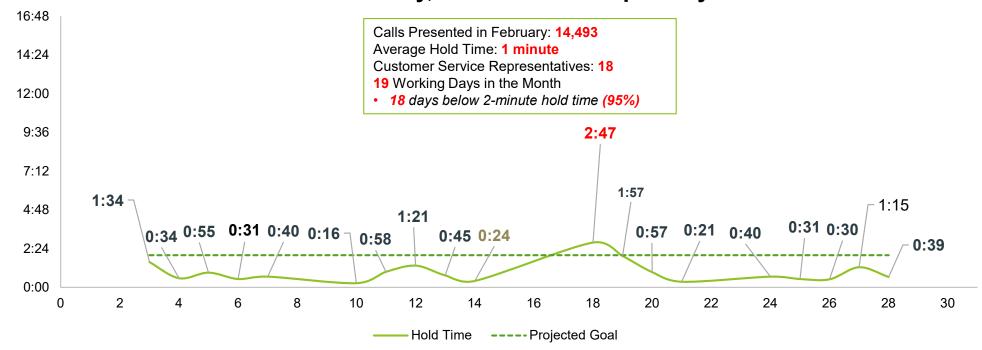

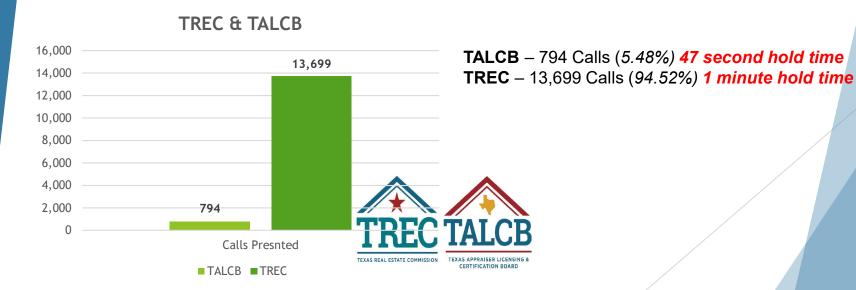

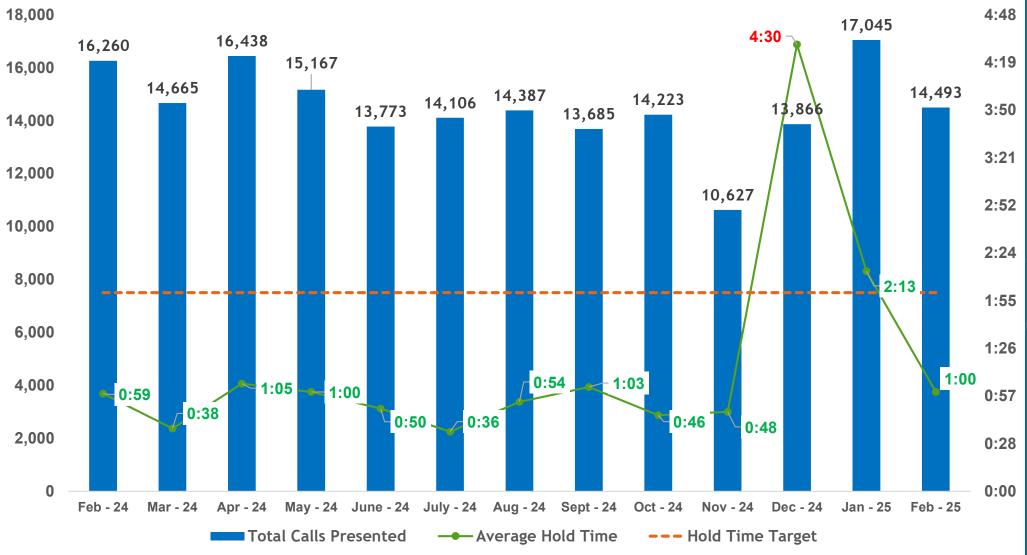


Customer Relations Division February, 2025 Hold Time per Day



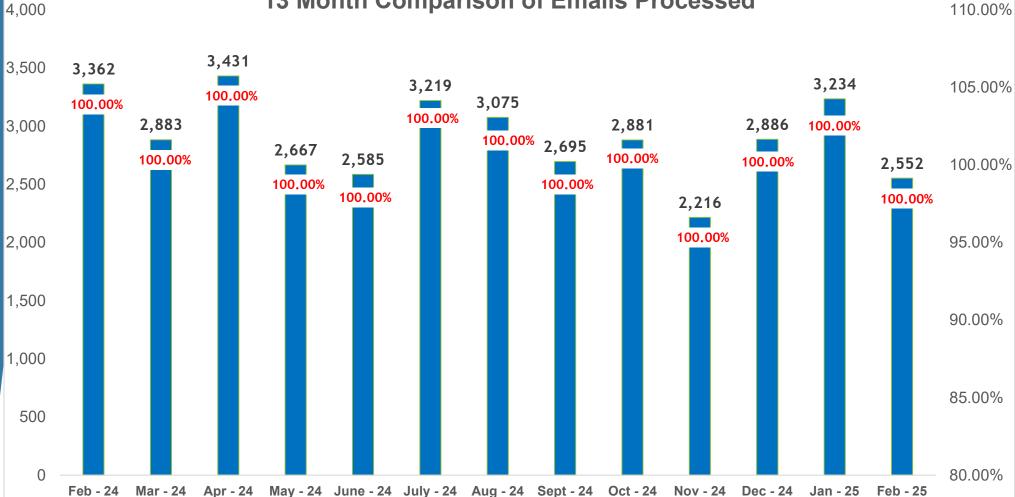


Customer Relations Division 13 Month Comparison of Calls Presented vs. Hold Time

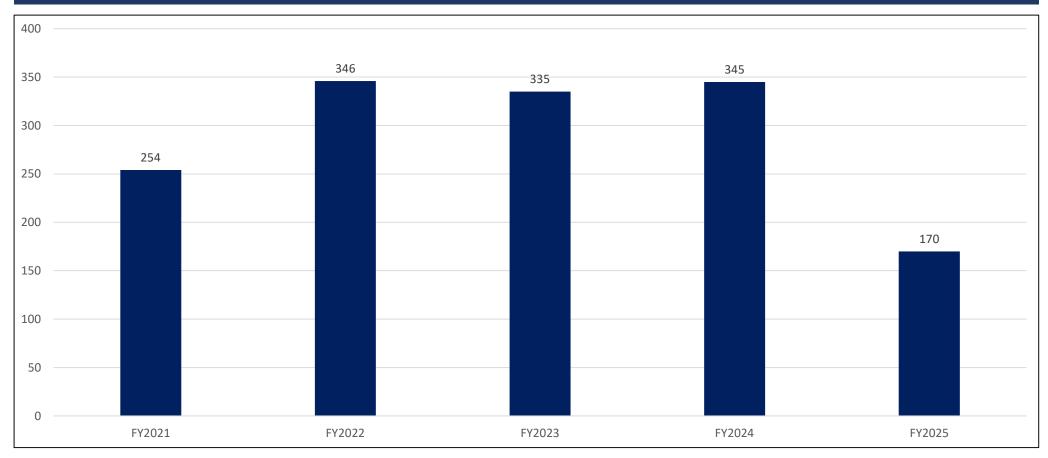
TALCB Total Applications Approved - Fiscal Year

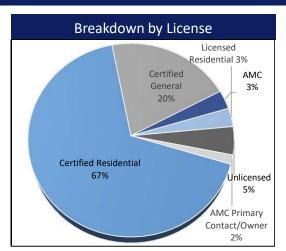


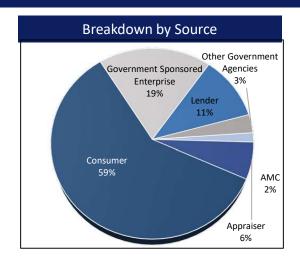




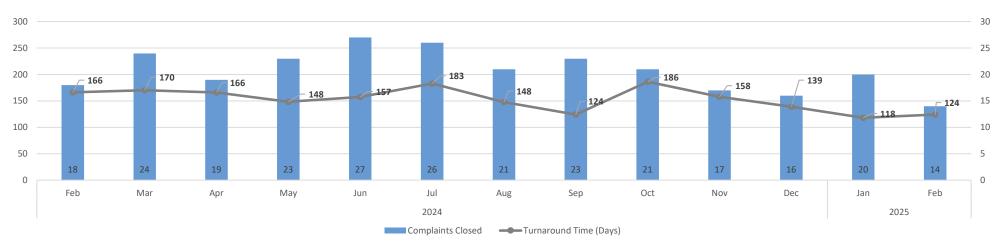
Fiscal Year 2025 Complaints Received by Category

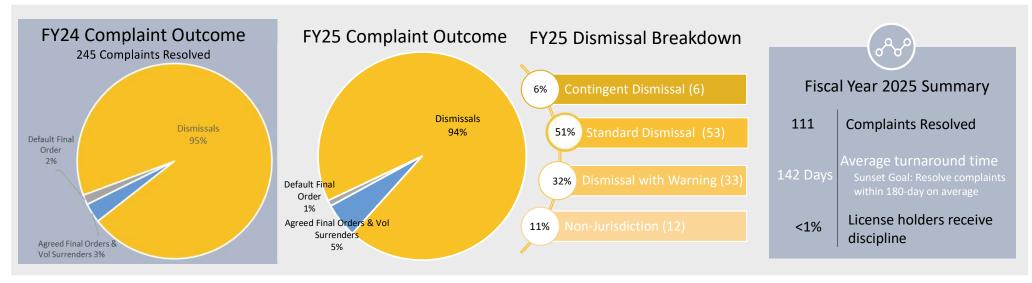




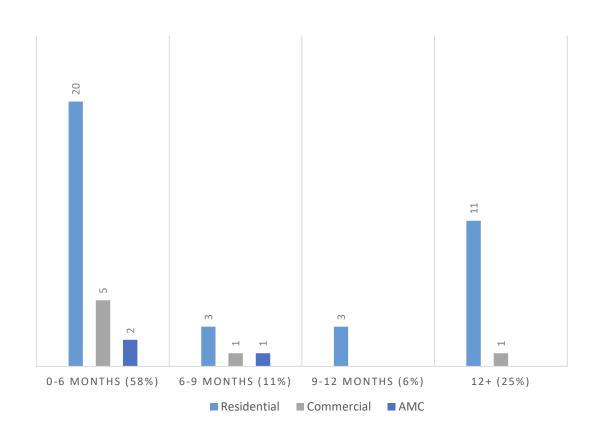


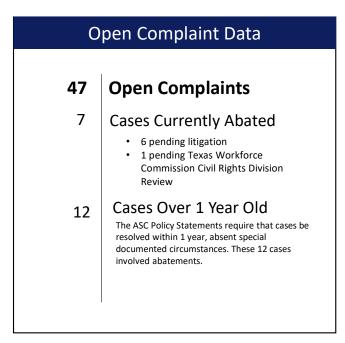
